them as shall be payable shall be paid to Her Majesty's Receiver of Rents for the County
 of Hunts free from all taxes and deductions whatsoever except Property Tax And
 the said John William Gooch Spicer doth hereby for himself his heirs executors
 and administrators Covenant with the Queen's Majesty her heirs and successors
 in manner following that is to say that he the said John William Gooch Spicer
 his executors administrators and assigns will pay to the Queen's Majesty her
 heirs and successors the said rent or rents hereinbefore reserved and made payable
 on the days and in manner aforesaid AND ALSO will from time to time during
 the continuance of this Licence kill and destroy and effectually keep down the hares
 and rabbits in and upon the said lands so as to prevent the number of them from
 increasing or impeding the good management of the said Lands or injuring the
 Crops Trees Shrubs and Fences thereon And in case the said John William Gooch
 Spicer his executors administrators or assigns shall neglect or omit so to do it shall
 be lawful for the said James Kenneth Howard or other the Commissioner or
 Commissioners for the time being of Her Majesty's Woods Forests and Land Revenues
 having the management of the said lands after giving to the said John William
 Gooch Spicer his executors administrators or assigns or leaving for him or them
 at his or their usual or last known place or places of abode in England seven
 days previous Notice in writing of his or their intention so to do to appoint and
 employ any person or persons to kill and destroy the said Rabbits and hares and
 reducing them to such numbers as shall in the opinion of the said James Kenneth
 Howard or such other Commissioner or Commissioners as aforesaid be consistent
 with the good management of the said Lands And the said John William Gooch
 Spicer his executors administrators or assigns will pay to the said James Kenneth
 Howard or such other Commissioner or Commissioners as aforesaid all the costs
 and expences to be incurred by the employment of such person or persons and also
 the amount of all damage occasioned by such neglect or omission or an account
 thereof in writing being delivered to or left for the said John William Gooch Spicer
 his executors administrators or assigns as aforesaid AND further that he the said John
 William Gooch Spicer his executors administrators and assigns will not during
 the continuance of this Licence commit or suffer any damage or injury to be done to
 the lands trees fences or crops of Her Majesty or of the Tenants or Occupiers of the said
 lands and premises and in case of any damage or injury being done to the said lands
 trees fences or crops as last aforesaid then that he the said John William Gooch Spicer
 his executors administrators or assigns will make full compensation and recompence
 to Her Majesty her heirs and successors or to the Tenants or Occupiers of the said
 Premises as the case may be for all such damage or injury as aforesaid AND
 ALSO that he the said John William Gooch Spicer will at the end or other sooner
 determination of the Licence hereby granted leave a fair and reasonable stock of
 Game on the said Premises and fish in the said pond And that he the said

John William Gooch Spicer with at the end or other sooner determination of the licence hereby granted have a fair and reasonable stock of game on the said premises and fish in the said pond and that for the said John William Gooch Spicer his executors or assigns will not transfer or assign grant or underlet or part with the licence hereby granted without the licence and consent in Writing of the said James Kenneth Howard or such other Commissioner or Commissioners for the time being as aforesaid first obtained And also will at his or their expence cause every Assignment of this licence made with such consent as aforesaid within one month from the date thereof to be enrolled in the Office of Land Revenue Records and Inrolments and a Minute or Pocket thereof to be entered in the Office of the Commissioners of Her Majesty's Woods Forests and Land Revenues Provided always And it is hereby declared and agreed that if the said several rents hereby reserved or such of them as shall from time to time be payable during the continuance of this licence or any part thereof respectively shall be unpaid for the space of twenty days next after either of the said days on which the same is ought to be paid as aforesaid or if the said John William Gooch Spicer his executors administrators or assigns shall not observe perform and keep the several Covenants hereinbefore contained and on his and their parts to be observed and performed then and in either of the said Cases it shall be lawful for the said James Kenneth Howard or other the Commissioner or Commissioners for the time being as aforesaid to annul determine and make void these Presents and the licence hereby granted by a Notice to that effect to be given to the said John William Gooch Spicer his executors administrators or assigns or left for him or them at his or their usual or last known place or places of abode in England Provided also And it is hereby further agreed that it shall be lawful for the said James Kenneth Howard or such other Commissioner or Commissioners for the time being as aforesaid to determine and put an end to this licence at any time of the Year by giving to or leaving for the said John William Gooch Spicer his executors administrators or assigns in manner hereinbefore mentioned fourteen days previous Notice in Writing for that purpose and upon the expiration of such Notice the said licence shall accordingly cease and be determined And the said James Kenneth Howard as such Commissioner as aforesaid doth hereby direct that these Presents shall be deemed to be fully and sufficiently enrolled by the deposit of a Duplicate thereof in the Office of Land Revenue Records and Inrolments and the filing or making an Entry of such deposit by the Keeper of the said Records and Inrolments In Witness whereof the said Parties to these Presents of the second and third parts have hereunto set their hands and seals the day and year first above written.

Whereas Josiah Stephens and Benjamin Stephens both of Clearwell in the Parish of Newland in the County of Gloucester now hold a Lode of an Iron Mine within the Forest of Dean & Hundred of Saint Briavels in the said County of Gloucester called the Clearwell Iron Mine and have requested John Atkinson the Deputy Gaveler of the said Forest of Dean to grant to them the said Josiah Stephens and Benjamin Stephens the Licence or right to make and form the Road after-mentioned and to have the use and enjoyment thereof as aftermentioned; and the Honorable James Kenneth Howard the Commissioner of Her Majesty's Woods Forests and Land Revenues, to whom the management and direction of the Royal Forests with the duties and powers appertaining thereto have been assigned by Order under the hands of the Lords Commissioners of Her

Majesty's Treasury hath signified his consent by a Writing under his hand that such Licence should be granted ^{to} therefore the said John Atkinson as such Deputy Gaveler as aforesaid in pursuance of all powers vested in him in this behalf and with such ^{consent} as aforesaid doth grant unto the said Josiah Stephens and Benjamin Stephens and all other persons
