**An Agreement** made and entered into this Third day of July one thousand eight hundred and fifty eight Between The Queen's Most Excellent Majesty of the first part The Honorable James Kenneth Howard The Commissioner of Her Majesty's Woods Forests and Land Revenues in charge of The Royal New Forest in the County of Hants of the second part and THOMAS LAUES of N<sup>o</sup> 32 City Road in the County of Middlesex Yeoman Merchant of the third part

Whereas the said Thomas Laues hath proposed to the Commissioners of Her Majesty's Woods Forests and Land Revenues to take and rent for the term of Thirty one years the lands and premises hereinafter more particularly mentioned subject to the payment of a yearly rent of Thirty pounds and upon the terms of his building or erecting a new Messuage or Dwellinghouse upon the premises or otherwise rebuilding the present Messuage or Dwellinghouse and Building or erecting certain offices and outbuildings there as hereinafter mentioned according to certain plans and Specifications already agreed upon and laying out & expending the sum of Two hundred pounds in making such Road and such drainage as after mentioned the Commissioners of Her Majesty's Woods Forests and Land Revenues at their own expence making and completing the whole of the external fencing of the said Lands and agreeing (in case the said sum of Two hundred pounds shall not be sufficient to complete the said Road and the requisite Drainage) to drain such of the said Lands as they shall think it necessary and the said Thomas Laues shall require to be drained upon condition that the said Thomas Laues pay a further rent of five pounds per cent per Annum upon all Monies which may be so expended by the said Commissioners Now these Presents Witness and the said Thomas Laues (hereinafter called the Lessee) Doth hereby for himself his heirs executors administrators and assigns Agree with the Queen's Majesty her heirs and Successors That he the said Lessee will at his own proper costs and charges within three years from the twentyfifth day of March one thousand eight hundred and fifty eight in a good substantial and workmanlike manner and with good sound and proper materials under the inspection and to the satisfaction of the said James Kenneth Howard or other the Commissioner or other Officer for the time being of Her Majesty's Woods Forests and Land Revenues in charge of the said Forest or his Surveyor or Agent for the time being and according to the plans sections and Elevations and the Specifications which have been approved of by the said James Kenneth Howard and have been signed by the said Thomas Laues and deposited in the Office of the Commissioners of Her Majesty's Woods Forests and Land Revenues erect and build or otherwise rebuild or

reinstate complete and finish in the place or stead of the existing Messuage & Buildings a good and substantial messuage or dwellinghouse with proper Offices and outbuildings and all necessary Sewers and Drains thereto and shall and will in such erections and buildings lay out and expend Six hundred pounds at the least And also will at his own expense and to the like satisfaction aforesaid lay out and expend the further sum of Two hundred pounds in making or forming a good hard road twelve feet wide for Horses & Carriages with proper Drains and Water Tables thereto from the said Dwellinghouse or Lodge to the Road leading from Breckenhurst to Beaulieu and in draining the said demised Lands or certain parts thereof with two inch pipes hollows not less than four feet deep nor wider apart than thirty feet and shall and will produce vouchers for all such Expenditure And these Presents further Witness and the said James Kenneth Howard as such Commissioner as aforesaid Doth hereby (subject to the approval of this Agreement by the Commissioners of Her Majesty's Treasury) agree with the said Lessee that when and so soon as the erections or Buildings and Works hereinbefore mentioned shall be completed and the Surveyor of the Commissioners of Her Majesty's Woods Forests and Land Revenues shall have certified in Writing that the same have been erected completed & finished in all respects to his satisfaction and according to the aforesaid plans sections elevations and specifications and the terms of this Agreement All the said James Kenneth Howard as such Commissioner as aforesaid or other the Commissioner or other Officer aforesaid shall and will by a good & sufficient Indenture of Lease to be prepared by the Solicitor for the time being acting on behalf of the Commissioner of Her Majesty's Woods Forests and Land Revenues in charge of the said Forest but at the costs and charges of the said Lessee demise and lease or cause to be demised and leased unto the said Lessee his executors administrators and assigns All several pieces or parcels of Land with the Messuage or Tenement and other Buildings erected or to be erected thereon and the yards gardens and orchards thereto belonging or appertaining situate and being in Whitley Ridge Walk in the New Forest in the County of Hants containing by estimation forty five Acres one rood and four perches more or particularly described in the Schedule hereunder written and delineated on the plan hereunto annexed (reserving to the Queen's Majesty all Timber and other Trees spires saplings and pollards and also all mines mineral substances Stone clay brick and tile earth sand and gravel with liberty to enter on the premises to view fell cut down grub up dig and search for get work dress take and carry away the same excepted premises and for all other necessary and reasonable purposes and also to make plans and take Surveys of the said premises and of the works erections and buildings from


time to time being erected thereon To hold for the term of Thirty one years from the twentyfifth day of March one thousand eight hundred and fifty eight at the yearly rent of Thirty pounds payable quarterly on the Twentyfourth day of June the twentyfifth day of September the twentyfifth day of December and the twentyfifth day of March in every year except in the last year of the said term in which the last two quarterly payments of rent shall be paid on the Quarter day next preceding the expiration of the said term free and clear of all rates taxes charges assessments and impositions whatsoever (except the Landlords Property Tax) And the said James Kenneth Howard as such Commissioner as aforesaid and subject to such approval as aforesaid hereby further Agrees to make and complete at the expense of the Commissioners of Her Majesty's Woods Forests and Land Revenues a proper and sufficient external fencing to the said lands and also that if the said Sum of Two hundred pounds so agreed to be laid out and expended by the said Thomas Cairns as aforesaid shall not be sufficient to complete the said Road and all the Drainage of the said Lands which the Commissioners for the time being of Her Majesty's Woods Forests and Land Revenues may think necessary that they will if required by the said Thomas Cairns so to do complete all such drainage at their own cost the said Thomas Cairns paying a further rent of five pounds per cent per Annum upon all monies which may be so expended And it is hereby mutually agreed by and between the said Parties hereto that the said lease shall contain the following Covenants on the part of the Lessee his executors admors and assigns videlicet

To pay the said Yearly Rent of Thirty pounds hereby reserved.

To pay a further rent of Forty pounds for every Acre of Meadow or pasture land and so in proportion for any less quantity than an Acre which shall be ploughed broken up or converted into Tillage or used otherwise than as Meadow or Pasture land without the consent in writing of the said James Kenneth Howard or other the Commissioner or Officer aforesaid and also a further rent of Ten pounds for every Acre and so in proportion for any less quantity than an Acre which at any time during the last five years of the said term the said Lessee shall neglect or discontinue to cultivate and manure according to the order or course of husbandry herein after mentioned.

And also to pay a further rent after the rate of five pounds per cent per Annum upon every one hundred pounds which shall be laid out or expended by the Commissioners of Her Majesty's Woods Forests and Land Revenues in Draining or underdraining any part of the said demised lands.

To pay the Land tax Sivers rate and all other taxes rates charges assessments and impositions whatsoever now or hereafter to be imposed (Landlords Property tax excepted.)

To repair and keep in good and substantial repair the Dwellinghouse  
 Outhouses and Outbuildings and all new or additional erections or buildings  
 to be erected upon the said premises together with all fixtures and other things  
 thereto belonging and to repair maintain cleave and keep all ways passages  
 watercourses gates stiles posts pales rails fences ditches and drains belonging  
 to the premises with all needful reparations and amendments whatsoever  
 without having or taking off or from the said premises any house bete hedge  
 bete or any other bete or botes or any stovers or timber whatsoever for the same  
 being allowed by the Commissioners of Her Majesty's Woods Forests and Land  
 Revenues sufficient timber in the rough towards all such repairs and at  
 the end of the term to yield up the said premises and all new erections and  
 fixtures and other things therein in good and sufficient repair & condition.

To permit and suffer the Commissioners of Her Majesty's Woods  
 Forests and Land Revenues or other the Commissioner or other officer aforesaid  
 or their or his Surveyor Agent or Agents to enter upon the premises at all  
 seasonable times to inspect the state thereof and take any plan of the same  
 and see the cultivation of the said lands and in case the premises shall  
 be out of repair, and notice thereof shall be given in writing that he the said  
 Lessee will within the space of three Calendar months next after every such  
 Notice repair and amend the same pursuant to such Notice and to the  
 satisfaction of the said Commissioners of Her Majesty's Woods Forests and  
 Land Revenues and in default thereof it shall be lawful for the said James  
 Kenneth Howard or other the Commissioner or Officer aforesaid to direct  
 the repairs to be done and to charge the said Lessee with the expence thereof  
 and to recover the same as Rent reserved.

To insure and keep the Messuage and all other Buildings to be  
 erected on the premises insured from fire during the said term in some  
 Insurance Office in London or Westminster to be approved of by the said  
 James Kenneth Howard or other the Commissioner or Officer aforesaid in a  
 sum which he shall deem to be not less than three fourths of the value of the  
 said Messuage and Buildings and in such name or names as he may  
 require such monies to be applied in rebuilding or repairing the property or  
 destroyed or damaged and in case the money to be received from such Insurance  
 shall not be sufficient to make good any damage happening by fire then the  
 said Lessee will make good the deficiency

To inbarn lay up and stack in the Barns Outhouses and other  
 convenient places upon the said premises all the Corn grain and hay which  
 shall be grown or produced thereon and consume upon the premises all such  
 hay and all the Straw Chaff and other fodder arising from such Corn and  
 grain and in a husbandlike manner spread and expence upon the Premises

all the dung compost and manure arising or proceeding therefrom

To farm and cultivate the said lands according to the most improved system of modern husbandry and according to their several natures & qualities

NOT to have more than one half of the Arable land under White Crops in the same year nor take two successive White Crops unless preceded by two successive green crops properly cleaned drilled and manured or after a Green Crops cleaned drilled and manured which shall have followed in immediate succession after a clover crops fully manured and unless both such White Crops shall be sown in rows and be horse or hand hoed and cleaned, and that the second of such White Crops and also each white Crops when taken without having been preceded by two such drilled Green crops shall always be succeeded by a drilled Green Crops properly cleaned and manured or by sown grapes or clover

To preserve from damage all the timber and other Trees Spires and Saplings on the premises but not to be required to enclose such Trees in rails or other fences.

To permit the Commissioners of Her Majesty's Woods Forests and Land Revenues and their Surveyor Agent or Servants at any time to enter upon the Premises to fell cut sell and carry away any Timber or other Trees Spires or Saplings without any allowance to the said Lessee for any damage which may be thereby occasioned if the same be done with proper care so as not to cause any unnecessary injury to the said lands and if the same be done at proper Seasons of the year

NOT to plough break up or convert into Tillage or Garden ground any of the pasture or meadow lands without the consent in Writing of the said James Kenneth Howard or other the Commissioner or Officer aforesaid or his or their Surveyor first obtained.

NOT to cut down fell strips tops tops or otherwise damage or destroy any timber or other Trees Spires or Saplings.

NOT to commit any Waste Spoil or destruction by digging pits upon the said lands (except Pits for drinking places for Cattle or for marling the lands) nor remove any Mineral Coal Lime or other Stone Gravel Sand Bricks earth clay marl or other soil or material (except marl for dressing the lands and materials for making or repairing the roads) without the consent of the said James Kenneth Howard or other the Commissioner or Officer aforesaid first had and obtained

NOT to commit any waste spoil or destruction upon the premises

NOT to sow during the last five years two white Crops in succession without a Fallow intervening or a Green crop properly hoed intervening and consumed on the premises

NOT to plant more than one crop of Potatoes in any one field during the last five years (Garden Ground excepted)

NOT to cut any of the Trees shoots from Stools or young plants under pretence of thinning them or of their being decayed or for any other reason whatsoever

NOT to erect build or set up any erection or building whatsoever without previous consent in Writing of the Commissioner in charge of Her Majesty's Woods Forests and Land Revenues.

TO lay down with Spring Corn at the Commencement of the last year such part of the lands as have been cultivated for Green Crops or Fallow in the preceding season with a sufficient quantity of Good Clover and other Grass Seeds to be paid for by Her Majesty or the incoming Tenant if not set with Sheep Horses or any kind of Cattle (other than Pigs well ringed) after the 29<sup>th</sup> of September preceding the expiration of the term.

TO permit Her Majesty or the incoming Tenant on the twenty fourth of August preceding the expiration of the term with Servants Horses and Carriages to enter upon the lands which shall have been in corn or pulse crops during the previous season or from which a Clover crop shall have been twice mown to prepare the same for cultivation and in like manner also to enter upon the lands sown in the last year with green crops after the same shall have been eaten likewise to prepare the same for cultivation without making any recompence to the said Lessee therefor and also to provide the incoming Tenant and his Servants and Horses with all necessary and reasonable room and accommodation from and after the respective times of entry aforesaid without any abatement of rent or other deduction or allowance and to permit the incoming Tenant to carry out and spread the dung and manure then being upon the premises upon the land so to be entered upon as aforesaid the value of such dung and manure being paid for according to a Valuation in the usual manner.

TO leave and yield up to Her Majesty or the Incoming Tenant on the determination of the said term such part of the last years crops of Hay and Straw and all such Dung compost or manure as shall then be remaining and shall not have been consumed upon the premises upon being paid for the same according to a Valuation thereof in the usual way

NOT to assign or underlet the premises or any part thereof or without the consent in writing of the said Commissioners for the time being of Her Majesty's Woods Forests and Land Revenues or one of them

And the said Lessee hereby agrees to execute a lease in duplicate of the said Farm and premises on the terms hereinbefore expressed when required so to do, and to pay all the costs and charges attending the preparation and enrolment of the same and of this agreement the said Lease to contain in addition to the foregoing Covenants a Proviso for reentry in case the

said Lease shall become Bankrupt or Insolvent or on nonpayment of the rent for sixty days or upon the breach or nonperformance of any of the covenants on the part of the said Lease and all the other clauses usually inserted in Crown Leases of a like nature. *IN WITNESS* whereof the said parties hereto of the second and third parts have hereunto set their hands the day and year first above written.



**This Indenture** made the fifteenth day of July in the Year of our Lord one thousand eight hundred and fifty eight **BETWEEN** The Queens Most Excellent Majesty of the first part **The Honorable James Kenneth Howard** the Commissioner of Her Majesty's Woods Forests and Land Revenues to whom the management and direction of certain parts of the Land Revenues of the Crown including (amongst other parts thereof) the hereditaments hereinafter described together with the duties and powers appertaining thereto have been assigned by order under the hands of the Commissioners of Her Majesty's Treasury of the second part and **Richard Aston and Edward Aston** both of Coleford in the County of Gloucester Free Miners of the Forest of Dean of the third part **WITNESSETH** that in consideration of the yearly rent hereinafter reserved and of the covenants hereinafter contained on the part of the said Richard Aston and Edward Aston their heirs executors administrators and assigns to be paid observed performed and kept **THAT** said James Kenneth Howard as such Commissioner as aforesaid by virtue and in exercise of the powers in him vested in and by certain Acts of Parliament passed in a Session held in the first and second years of the Reign of Her present Majesty Cap 43 and in another Session held in the fourteenth and fifteenth years of the Reign of Her present Majesty Cap 112 or one of them and of all other powers in him vested or in anywise enabling him so to do **DOETH** by these Presents for and on behalf of the Queen's Majesty grant full power licence and authority unto the said Richard Aston and Edward Aston their executors administrators and assigns at their own expence during the term hereby granted to dig and get sand off from and out of **All that** piece or parcel of Land part of the Open Waste Lands of Her Majesty's Forest of Dean in the County of Gloucester situate lying and being at Berry Hill in Worcester Walk in the said Forest and containing by admeasurement one rood and twentyfour perches bounded on all sides by open Waste situate at a distance of fortyfour yards or thereabouts to the Westward of a certain Encroachment now belonging to Richard Whittington Numbered 176 on the plan of Encroachments in Worcester Walk annexed to the second Report of the Commissioners appointed under the first and second William 4<sup>th</sup> Cap 12 which said piece or parcel of Land is now staked out from the open Forest, and is more particularly delineated and described on the plan thereof drawn in the margin of these Presents and thereon colored Red **TO HOLD** use exercise and enjoy the said power licence and authority hereby granted unto the said Richard Aston and Edward Aston their executors administrators & assigns from the twentyfourth day of June one thousand eight hundred and fifty eight for the term of **Twenty one Years** Paying therefore yearly and every year during the said term unto the Queen's Majesty her heirs &

Successors the clear yearly rent or sum of **TWO POUNDS** of lawful money of Great Britain to be paid half yearly on the twentyfifth day of December and the twenty fourth day of June in every year by equal payments free and clear of land tax and of all other Taxes and assessments whatsoever which now are or shall at any time hereafter during the said term be imposed upon or in respect of the said premises the first half yearly payment thereof to begin and be made on the twentyfifth day of December One thousand eight hundred and fifty eight AND the said Richard Aston and Edward Aston do hereby for themselves their heirs executors and administrators and each of them doth hereby for himself his heirs executors and administrators covenant with the Queens Majesty her heirs and successors That they the said Richard Aston and Edward Aston their executors administrators and assigns shall and will from time to time during the said term hereby granted well and truly pay or cause to be paid unto the Queens Majesty her heirs Successors the said rent hereinbefore reserved upon the respective days and times and in the manner and proportions hereinbefore mentioned and appointed for payment thereof free and clear of all manner of Taxes and Assessments whatsoever AND ALSO that if default shall be made for the space of thirty days in payment of the aforesaid rent then and so often it shall and may be lawful to and for the Queens Majesty her heirs and successors or the said James Kenneth Howard or other the Commissioner or other Officer or Officers for the time being

of Her Majesty's Woods Forests and Landrevenues exercising the powers now exercised by the said James Kenneth Howard or her heirs or their Agent or Agents from time to time to seize and distrain all or any Machinery Engines Implements Utensils horses carts carriages or other live or dead Stock and all the found and other things which shall be remaining at and upon the land herein before described or

 and payment of all such rent of which such default shall be made in payment  
 as aforesaid and also of all costs and charges incident to or occasional by such  
 distress or distresses in the like and as full and ample manner and form as any  
 rent whatsoever can or may be recovered by law *AND ALSO* that they the said  
 Richard Aston and Edward Aston their executors administrators and assigns  
 shall and will during the said term pay and discharge the land tax (if any)  
 and all other taxes rates tithes charges payments assessments impositions and  
 outgoings of what nature or kind soever which may be charged rated assessed  
 or imposed upon or in respect of the said Premises and every part thereof  
*AND ALSO* will forthwith enclose and fence in the said piece or parcel of  
 land to the satisfaction of the said James Kenneth Howard or other the  
 Commissioner or other Officer or Officers of Her Majesty as aforesaid and will  
 during the continuance of this demise at their own costs keep the same so well  
 and sufficiently inclosed and fenced in as aforesaid *AND ALSO* will during  
 the continuance of the said term fairly and effectually work and carry on all  
 and every Pits and Works for the time being open or to be opened in and upon  
 the said Premises for the purpose of getting sand off from or out of the same  
 to the satisfaction of the said James Kenneth Howard or other the Commissioner  
 or other Officer of Her Majesty as aforesaid and shall not in any manner use  
 the said land hereinbefore described except for the purpose of digging or getting  
 sand off from or out of the same as aforesaid *AND ALSO* that it shall and  
 may be lawful to and for the Queens Majesty her heirs and successors and  
 also for the said James Kenneth Howard or other the Commissioner or  
 other Officer or Officers of Her Majesty for the time being as aforesaid and her  
 his and their or any of their Agents at all times at her his and their pleasure  
 to employ any person or persons to inspect all and singular the premises aforesaid  
 and the state and condition thereof and if any error fault or defect shall be  
 found or appear in the working or conducting of all or any part of the said  
 Works and Premises that then the said Richard Aston and Edward Aston  
 their executors administrators or assigns shall and will on receiving Notice to  
 that effect repair correct and amend the same within the space of two Calendar  
 months next after the date of such Notice *AND ALSO* that they the said  
 Richard Aston and Edward Aston their executors administrators and assigns  
 shall not nor will at any time or times during the said term hereby granted  
 erect build or set up upon the said lands or any part thereof any Manufactory  
 or any other erection or building whatsoever And shall not nor will commit any  
 unnecessary damage spoil or waste in or upon the aforesaid land and premises  
 or any part thereof in the exercise of the power hereinbefore contained nor use the  
 same except for the purpose of digging and getting sand off from or out of the

same and shall not nor will in the exercise of the power hereinbefore contained  
 do or permit or suffer to be done any damage spoil or injury to any of the wood  
 timber or other trees belonging to Her Majesty in the said Forest and shall and  
 will at the end or other sooner determination of the said term hereby granted fill up  
 in a proper and substantial manner and to the satisfaction of the said James  
 Kenneth Howard or other the Commissioner or other Officer or Officers of Her  
 Majesty for the time being as aforesaid or his or their Agent all such Pits as may  
 have been made in digging and getting Sand off and out of the said piece or  
 parcel of land and shall and will level and restore such land as far as is practicable  
 to its present state and condition and that they the said Richard Aston and  
 Edward Aston their executors shall not nor will transfer or assign over grant  
 or underlet or otherwise part with to any person or persons whomsoever the  
 works matters and things liberties authorities privileges and premises hereinbefore  
 granted respectively or any of them or any part thereof for the whole or any  
 part of the term hereby granted without the consent and approbation in  
 writing of the Queens Majesty her heirs or successors or of the said James  
 Kenneth Howard or other the Commissioner or other Officer or Officers of Her  
 Majesty for the time being as aforesaid for that purpose first had and obtained  
 And also that they the said Richard Aston and Edward Aston their  
 executors assigns or assigns shall and will at their own expence cause and procure
