

By the Honorable James Kenneth Howard, one of the Commissioners of Her Majesty's Woods Forests and Land Revenues.

Know all Men by these Presents That I, The Honorable James Kenneth Howard the Commissioner of Her Majesty's Woods Forests and Land Revenues to whom the management and direction of certain parts of the Land Revenues of the Crown including among other parts thereof the hereditaments hereinafter granted with the duties and powers appertaining thereto have been assigned by an Order under the hands of two of the Commissioners of Her Majesty's Treasury on behalf of Her Majesty and under the authority of an Act passed in the tenth year of the Reign of His late Majesty King George the Fourth intituled 'An Act to consolidate and amend the Laws relating to the management and improvement of His Majesty's Woods Forests Parks and Chases of the Land Revenue of the Crown within the Survey of the Exchequer in England and of the Land Revenue of the Crown in Ireland and for extending certain provisions relating to the same to the Isles of Man and Alderney'. And also of an Act passed in the fourteenth and fifteenth years of the reign of Her present Majesty Queen Victoria intituled 'An Act to make better provision for the management of the Woods Forests and Land Revenues of the Crown and for the direction of public Roads and Buildings'. In consideration of the sum of Ten pounds by Elam Chivers of Ruardean Hill near Mitcheldean in the County of Gloucester Engine Driver paid to the said Commissioner before the sealing and delivery of these presents grant unto the said Elam Chivers and his heirs all the estate right title and interest of the Queens Majesty of in and to All that piece or parcel of waste land of Her Majesty's Forest of Dean in the County of Gloucester situate and being on Ruardean Hill in Ruardean Walk in the said Forest and containing by recent admeasurement Ten perches



and adjoining to premises now belonging to the said Elam Chivers formerly an Incroachment and numbered 365 on the plan of Incroachments in Ruardean Walk annexed to the second Report of the Commissioners appointed under the first and second William 4 Cap 12 which said piece or parcel of land had by

conveyed is more particularly delineated and described with its boundaries and abutments on the plan drawn in the margin hereof and thereon colored Red (save and except out of this grant all mines and minerals within upon or or under the said piece or parcel of land and premises or any part or parcel thereof with full power to Her Majesty Her Heirs Successors and assigns and Her and their Heirs Tenants Servants Agents and Workmen from time to time and at all times for ever hereafter to enter upon work use and enjoy the same and every of them as fully and effectually to all intents and purposes as if this grant had not been made) Together with all and singular ways paths passages waters watercourses hedges ditches fences easements profits commodities advantages emoluments and appurtenances whatsoever to the said piece or parcel of land and premises or any part or parcel thereof belonging or appertaining or therewith or with any part or parcel thereof held used occupied or enjoyed which said piece or parcel of land and premises formed part of the possessions or Land Revenues of the Crown within the ordering and survey of the Court of Exchequer To have and to hold the said piece or parcel of land and premises hereby granted and all benefits and advantages thereto belonging (except as aforesaid) unto the said Ham Chivers and his heirs and assigns for ever AND I the said James Kenneth Howard do hereby direct that this Deed shall be deemed to be fully and sufficiently enrolled by the deposit of a Duplicate thereof in the Office of Land Revenue Records and Inrolments and the filing or making an Entry of such Deposit by the Keeper of the said Records and Inrolments. 

 unpaid for thirty days next after either of the days of payment on  
 which the same ought to be paid or if the said Baron Gould John Heyworth  
 and William Philip Price their executors administrators and assigns and

assigns and every of them do not in all things observe perform and keep all and singular the covenants provisoes conditions and restrictions herein contained and on their parts to be performed and kept according to the true intent and meaning of these presents then and from thenceforth and in any of such cases it shall be lawful for Her Majesty Her Heirs and Successors or the said James Kenneth Howard as such Commissioner as aforesaid or other the Commissioner or other Officer or Officers aforesaid on behalf of Her Majesty Her Heirs and Successors into and upon the said demised premises or any part of the same in the name of the whole to reenter and the same thenceforth to have again retain reposseand enjoy as in her or their former estate and the said Claren Goold John Heyworth and William Philip Price their executors administrators and assigns and every of them and all other occupiers thereof thereout and from thence to expel put out and amove this present Indenture or anything herein contained to the contrary thereof notwithstanding And the said James Kenneth Howard doth hereby direct that this deed shall be deemed to be fully and sufficiently enrolled by the deposit of a Duplicate thereof in the Office of Land Revenue Records and Inrolments and the filing or making of an entry of such Deposit by the Keeper of the said Records and Inrolments. 

This Indenture made the twenty fifth day of October one thousand eight hundred and fifty eight Between The Queen's Most Excellent Majesty of the first part The Honorable James Kenneth Howard the Commissioner of Her Majesty's Woods Forests and Land Revenues to whom the management and direction of the Royal Forest of Dean with the duties and powers appertaining thereto have been duly assigned under the Act fourteenth and fifteenth Victoria Chapter 42 Section 5 of the second part and Joseph Dawson a Shop keeper and James Jones a Miner both of Mitcheldean in the County of Gloucester Ewing Pye de Colquhoun of No 3 Stratford place Oxford Street in the County of Middlesex Student at Law Henry William Bristow of the Geological Survey of England Geological Surveyor and Richard Gibbs of the Geological Survey Fossil Collector of the third part Whereas the said several persons parties hereto of the third part are the Registered Owners of a certain Gate or Colliery in the said Forest of Dean called or known as Morse's Level Gate and as such Registered Owners lately applied to the said James Kenneth Howard as such Commissioner as aforesaid (in whom the powers given to the Commissioners for the time being of Her Majesty's Woods Forests Land Revenues Works and Buildings by the Act first and second Victoria Chapter 43 are now vested) to grant to them a lease of the piece or parcel of Land part of the uninclosed wasteland of the said Forest hereinafter more particularly described for the purposes hereinafter mentioned And whereas the said James Kenneth Howard as such Commissioner as aforesaid hath agreed to grant such lease to the said several persons parties hereto of the third part for such term at such Rent upon such conditions and subject to such covenants and restrictions as are hereinafter reserved and contained Now this Indenture witnesseth that in consideration of the premises The said James Kenneth Howard as such Commissioner as aforesaid by virtue of every power enabling him so to do Doth by these presents demise and lease unto the said Joseph Dawson James Jones Ewing Pye de Colquhoun Henry William Bristow and Richard Gibbs their executors administrators and assigns All that piece or parcel of Land situate lying and being at Howbeach Valley in Blakeney Walk in the Forest of Dean and County of Gloucester containing by recent admeasurement one acre bounded on the south west by the Turnpike Road leading from park end to Blakeney on the north west and south east by open Forest and on




