made and entered into this 13th day of February 1861. Between The Honorable James Kenneth Howard the Commissioner of Her Majesty's Woods Forests and Land Revenues to whom the management and direction of certain of the Woods Forests and Land Revenues of the Crown including (amongst others) the Royal Forest of Dean in the County of Gloucester with the duties and powers appertaining thereto have been assigned by Order under the hands of the Commissioners of Her Majesty's Treasury the said James Kenneth Howard being also the Gavelor of the said Forest of Dean of the one part and Mary Hathaway of Thud Newton Rectory near Chepstow in the County of Monmouthshire of the other part.

Thomas Sopwith of Newcastle upon Tyne in the County of Northumberland Mining Engineer John Polyn of Gloucester Esquire and John Buddle of Walls End in the said County of Northumberland Mining Engineer (being the Commissioners appointed by an Act passed in the first and second years of the Reign of Her present Majesty (Cap: 113) intituled "An Act for regulating the opening and working of Mines and Quarries in the Forest of Dean and Hundred of St. Briavels in the County of Gloucester" for carrying the purposes of the said Act into effect and therein styled the Dean Forest Mining Commissioners) duly made and published their Award in writing relating to Quarries in the said Forest bearing dated on or about the 21st day of July 1841 And whereas Elizabeth Hathaway and William James in the said Award described as both of Bream in the said Forest of Dean were by the said Award declared to be in possession of or entitled to in equal undivided moieties (as claiming through or under Free Miners) one Gale for the purpose of working a Quarry in the said Forest situate at Breams Tuffs of three lengths numbered 114 and in the First Schedule to the said Award described as follows "All that quarry at Bream Tuffs numbered 114 extending in length sixty yards and bounded as shewn on Plan 36" annexed to the said Award Paying unto Her Majesty her heirs and successors in respect thereof such rent or sum per Annum as by the said Award and the said Act are directed to be paid in respect thereof and subject also to the observance and performance of such General Rules orders and regulations for the working of the said Gales and Quarries as were and are set forth and comprised in the second Schedule to the said Award And whereas the said Elizabeth Hathaway departed this life before the 29th day of September 1859 whereby the Rent of the undivided Moiety of the said Quarry so awarded to her as aforesaid ceased at that period And whereas the said Mary Hathaway is the person now in possession of or entitled to

day of September for and during the then residue of the said term of Twenty

and assigns shall and will on the 29th day of September yearly and every
year for the term of twenty one years to be computed from the 29th day of
September 1859 pay or cause to be paid unto the Queen's Majesty her heirs
and successors for and in respect of the said Quarry the said Rent or Rents
of One pound fifteen shillings and Three pounds respectively so agreed upon
as aforesaid without any deduction or abatement whatsoever as and when
the same shall respectively fall due as hereinafter mentioned, that is to say,
From and after the 29th day of September One thousand eight hundred and
fifty nine up to the 29th day of September which shall first happen next
after the death of the said William James (if he shall happen to die during
the said term of twenty one years) the said rent or sum of One pound
fifteen shillings And from and after the said 29th day of September
which shall first happen next after the death of the said William James
for and during the then unexpired residue of the said term of twenty one
years then Yielding and Paying the said rent or sum of Three pounds
And further that she the said Mary Hathaway her heirs executors
administrators and assigns shall and will from time to time and at all
times during the said term abide by perform fulfil and keep all and
singular the aforesaid Rules Orders and Regulations made by the said Dean
Forest Mining Commissioners for the working of the said Quarries And
if the said James Kenneth Howard do hereby direct that this Deed shall

be deemed to be well and sufficiently enrolled by the deposit of a duplicate thereof in the Office of Land Revenue Records or Enrolments and the filing or making an entry of such deposit by the Keeper of the said Records and Enrolments. Articles of Agreement made the 29th day of July 1861.
Between The Queen's Most Excellent Majesty of the first part
The Honorable James Kenneth Howard the Commissioner of
Her Majesty's Woods Forests and Land Revenues having the management
and direction of the Forest of Bere in the County of Hants of the second
part and William Mulford of Greywell in the County of Hants
Timber Merchant of the third part.

The said James Kenneth Howard on behalf of Her Majesty agrees to sell to the
said William Mulford and the said William Mulford agrees to purchase of Her
Majesty at the price of One shilling and sixpence per foot 520 Timber Trees lately
felled in the said Forest of Bere And the said William Mulford agrees to pay to
Her Majesty the sum of £111. 8. 8 as a deposit on the signing of this Contract and
to pay the remainder of the said purchase money, £565. 11s. 10 within 6 Calendar
months from the date hereof And as a further security for the payment of the
remainder of the said purchase money the said William Mulford agrees to give to
the said James Kenneth Howard on the signing of this Contract the joint and several
promissory Note of hand of the said William Mulford of Greywell in the County
of Hants Robert Hewitt of Windfield in the same County and George Hewitt of
South Manton in the same County for the amount thereof payable on the
29th day of January 1862 And the said William Mulford also agrees to accept
and take the whole of the Timber as already measured and will not require any
new admasurement thereof and will bear the risk of all damage and injury that
may happen to the said Timber until the same shall have been removed from
off the said Land, and also will remove and clear off from the said Land the
whole of the said Timber hereby agreed to be sold on or before the 30th day of
November 1861 and will also use only such Roadways and other places upon
the Crown lands for the purpose of removing the said Timber as may be set out
or allowed for that purpose by the Receiver of Crown Rents for the County of
Hants And also will pay and make good to Her Majesty and her Lessees and
Tenants for all damage that may be done by him the said William Mulford or
his Agents Carts or Horses to any of the lands belonging to Her Majesty or the trees
fences or crops thereon in removing the said Timber the amount of which damage
shall be estimated and determined by the said Receiver of Crown Rents whose






