



Dated 13th This Indenture made the thirteenth day of August August 1862 One thousand eight hundred and sixty two Between Joseph Scudamore of Abinghall near Mitcheldean in the County of Gloucester Gentleman of Forest of Dean the first part The Queen's Most Excellent Majesty of the second part and The Honorable James Kenneth Howard the Commissioner of Her Majesty's Woods Forests and Land Revenues to whom the management and direction of certain of the Woods Forests and Land Revenues of the Crown including therein the Royal Forest of Dean with the duties and powers appertaining thereto have been assigned by Order under the hands of the Lords Commissioners of Her Majesty's Treasury made in pursuance of the Act 11th and 15th of Victoria Chap 12

W. Joseph Scudamore heretofore mentioned of the third part Whereas John Scudamore late Most Excellent Majesty's seized of or otherwise well entitled to him and his heirs for an Estate of Inheritance in fee simple in possession (free from incumbrances) of and in the two pieces or parcels of land and premises hereinafter particularly described and hereby intended to be conveyed in exchange duly made and (by way of exchange) published his last Will and Testament in writing bearing date the of two pieces of twelfth day of June One thousand eight hundred and forty eight whereby Land in Little Dean Walk and other hereditaments) the two pieces or parcels of land and premises the Forest of hereinafter more particularly described unto and to the use of his (the Dean and County said Testator) Son the said Joseph Scudamore upon his attaining the of Gloucester age of Twenty one years his heirs and assigns for ever And the said Testator appointed James Young of Newent in the County of Gloucester Farmer and his Son James Scudamore Executors In trust of his said Will And whereas the said Testator made two Codicils to his said Will dated respectively the twenty second of March and the eleventh of April One thousand eight hundred and fifty one but neither of the said Codicils in any way affected the aforesaid Devises to his said Son Joseph or the Appointment of his said Executors And whereas the said Testator departed this life on or about the fourteenth day of April One thousand eight hundred and fifty one without having altered or revoked his said Will save and except as by the said two Codicils and the said Will and Codicils were duly proved by the said Executors in the Consistory Court of Gloucester on the seventeenth day of March One thousand eight hundred and fifty two And whereas the said Joseph Scudamore attained the age of twenty one years on the thirteenth day of December One thousand eight hundred and forty nine And whereas by the tenth George Fourth Chapter 50 Section 98 It was

amongst other things enacted that it should be lawful for the Commissioners for the time being of Her Majesty's Woods Forests and Land Revenues and they were thereby authorized and empowered from time to time to contract and agree with any person or persons Body or Bodies Politic Corporate or Collegiate for the Sale or Exchange of and absolutely to dispose of either by way of Sale for such sum or sums of money as to them should appear a sufficient consideration for the same or by way of Exchange for any other lands or hereditaments with or without giving or receiving any sum of money for equality of Exchange any part or parts of the said possessions and Land Revenues of the Crown to which the now reciting Act related which should consist of any parcels of Land in any of the Royal Forests which were or might be wholly or in part surrounded by intermixed with or contiguous to other Lands not the property of the Crown and which parcels of Land should not be suited for the growth of Timber or any Waste or other Lands in any of the Royal Forests which should not exceed in value in any one instance the sum of One thousand pounds and every such Sale and exchange should be carried into effect in such and the like manner as was theretofore directed with respect to other parts of the Land Revenues of the Crown to which the now reciting Act related And whereas by the second William Fourth Chapter 1 the Office of the Surveyor General of His Majesty's Works and Public Buildings was united with the Office of the Commissioners of His Majesty's Woods Forests and Land Revenues and persons to be appointed as in the said Act mentioned and their Successors were thereby directed to be called The Commissioners of His Majesty's Woods Forests Land Revenues Works and Buildings And whereas by the 11th and 15th Victoria Chapter 42 It was enacted that from and after the commencement of the said Act the persons who at the time of the commencement of the said Act might be Commissioners of Her Majesty's Woods Forests Land Revenues Works and Buildings (except the First Commissioner) should be Commissioners under the said Act by the style of "The Commissioner of Her Majesty's Woods Forests and Land Revenues" and that except as otherwise in the said Act provided all duties and powers which if the said Act had not been passed would have been performed and exercised and all rights privileges hereditaments properties and exemptions whatsoever enjoyed by or vested in the Commissioners of Her Majesty's Woods Forests Land Revenues Works and Buildings or the First Commissioner of Her Majesty's Woods Forests and Land Revenues Works and Buildings for the time being should be performed and exercised, enjoyed or vested by and in the Commissioners of Her Majesty's Woods



Forests and Land Revenues for the time being under the said Act -
 and except as otherwise provided by the said Act all Acts of
 Parliament Deeds Bonds Contracts Agreements and other Instruments
 in which the Commissioners or First Commissioner of Her Majesty's
 Woods Forests Land Revenues Works and Buildings or the Commissioners
 or First Commissioner of Her Majesty's Woods Forests and Land Revenues
 were or was named or mentioned should apply to the Commissioners
 for the time being of Her Majesty's Woods Forests and Land Revenues
 under the said Acts as if such last mentioned Commissioners had been
 originally named or mentioned therein And it was by the Act now in
 recital further enacted that it should be lawful for the Commissioners
 of Her Majesty's Treasury from time to time as they might see fit by
 Order under their hands to assign to each of the Commissioners of Her
 Majesty's Woods Forests and Land Revenues the management or
 direction of or in relation to any separate part or parts of the Woods
 Forests and Land Revenues under the management of such Commissioners
 and to assign to each of such Commissioners any of the duties or powers
 which but for such assignment should or might be performed or
 exercised by such Commissioners jointly and all acts in relation to
 the management or direction duties or powers assigned as aforesaid to
 each of such Commissioners might be done by the Commissioner to
 whom the same was or were assigned and should be as valid and
 effectual as if done by both such Commissioners And whereas
 the said Joseph Scudamore lately contracted and agreed with the
 said James Kenneth Howard as such Commissioner of Her Majesty's
 Woods Forests and Land Revenues as hereinbefore expressed acting for
 and on behalf of Her Majesty and with the consent and authority
 of the Lords Commissioners of Her Majesty's Treasury signified by
 Warrant in writing under the hands of two of them bearing date the
 nineteenth day of April One thousand eight hundred and sixty two
 for the purchase of the two pieces or parcels of Land and hereditaments
 hereinafter more particularly described and intended to be conveyed
 to The Queen's Majesty by way of Exchange for the eight several pieces
 or parcels of Waste land in the said Forest of Dean conveyed or intended
 to be conveyed by the said James Kenneth Howard as such Commissioner
 as aforesaid to the said Joseph Scudamore and his heirs by Indenture
 of even date herewith with the addition of the sum of Seventy one
 pounds ten shillings to be paid to the said Joseph Scudamore for
 equality of exchange Now this Indenture witnesseth that in
 pursuance of the said recited Contract and Agreement and in

consideration of the conveyance to the said Joseph Suddamore and his heirs by the said James Kenneth Howard (as such Commissioner as aforesaid) by a Deed Poll under his hand and seal intended to bear even date herewith of the eight several pieces or parcels of waste land in the said Forest of Dean colour'd Red on the plan drawn in the margin of these presents And also in consideration of the sum of Seventy one pounds ten shillings by way of equality of exchange to the said Joseph Suddamore in hand well and truly paid by the said James Kenneth Howard as such Commissioner as aforesaid on behalf of Her Majesty at or before the sealing and delivery of these presents the receipt whereof he the said Joseph Suddamore doth hereby acknowledge and thereof and therefrom doth acquit release and discharge the said James Kenneth Howard as such Commissioner as aforesaid and also the Queen's Majesty her heirs and Successors The said Joseph Suddamore at the request and by the direction of the said James Kenneth Howard (as such Commissioner as aforesaid) Doth by these Presents grant convey and confirm unto the Queen's Majesty her heirs and successors

Firstly All that piece or parcel of Land or Orchard commonly called or known by the name of Wood Patch situate lying and being at or near the Southern point of Edge Hills Inclosure in Little Dean Walk in the Forest of Dean and Hundred of St. Briavels in the said County of Gloucester containing by admeasurement two acres two roods and nine perches or thereabouts for many years past in the occupation of Jonathan Bryan deceased or his Sons James and Jonathan Bryan respectively deceased and formerly called Bryans or Brains Orchard and now in the possession or occupation of the said Joseph Suddamore and bounded on the East in part by the Turnpike Road called Littledean Lane leading from Littledean to Gynemills on the South by other lands of the said Joseph Suddamore in the parish of Littledean and on all other parts or sides by open Forest

 said Joseph Scudamore or by the said John Scudamore deceased or either
 of them or by any person or persons whomsoever claiming or to claim by
 from through under or in trust for them or either of them And
 further that he the said Joseph Scudamore and his heirs and all
 and every other person or persons whomsoever lawfully or equitably
 claiming or to claim as aforesaid shall and will from time to time
 and at all times hereafter upon every reasonable request and at the
 proper costs and charges of the Queen's Majesty her heirs and successors
 or of the Commissioners of Her Majesty's Woods Forests and Land Revenues
 for the time being or one of them make do and execute or cause or procure
 to be made done and executed all and every such further and other lawful
 and reasonable acts deeds Conveyances and Assurances in the law
 whatsoever for the further better more perfectly and absolutely granting
 and conveying in exchange the said pieces or parcels of land and
 hereditaments hereinbefore described and hereby conveyed in exchange or
 intended so to be with the appurtenances unto and to the use of the
 Queen's Majesty her heirs and successors in manner aforesaid and
 according to the true intent and meaning of these presents as by the
 Queen's Majesty her heirs and successors or by the said James Kenneth
 Howard as such Commissioner as aforesaid or the Commissioners for the
 time being of Her Majesty's Woods Forests and Land Revenues or one of
 them or by the Law Officers of Her Majesty her heirs and successors
 shall be reasonably devised or advised and required And the said
 James Kenneth Howard doth hereby direct that this Deed shall be deemed
