Deed of Covenant

for payment of additional yearly rents.

This Indenture made the fifth day of December One thousand eight hundred and sixty six Between The within named Henry Thompson of the first part the within named James Kenneth Howard of the second part and The Queen's most Excellent Majesty of the third part Whereas the sum of Five thousand and ninety nine pounds two shillings and eight pence has at the request of the said Henry Thompson been laid out and expended by the said James Kenneth Howard on behalf of The Queen's Majesty in the erection of a Farmhouse and Offices and a Bailiffs House and Laborers Cottages on the land demised by the within written Indenture which is dated the twenty first day of August One thousand eight hundred and sixty three and is made between The Queen's Majesty of the first part the said James Kenneth Howard of the second part and the said Henry Thompson of the third part And the further sum of Three hundred and forty nine pounds six shillings and seven pence has also been expended by the said James Kenneth Howard on behalf of Her Majesty in draining and fencing the said land and the sum of Three hundred and ten pounds five shillings and seven pence has also with the consent of the said Henry Thompson been expended on behalf of Her Majesty in making roads upon part of the said Land And whereas under and by virtue of the reservations contained in the within written Indenture the several additional yearly rents following have become payable by the said Henry Thompson to The Queen's Majesty in respect of the sums so expended as aforesaid from the periods hereinafter mentioned during the remainder of the term granted by the said Indenture, that is to say, the further yearly rent of Two hundred and seventy one pounds eight shillings and four pence from the tenth day of October One thousand eight hundred and sixty five on account of the aforesaid expenditure of Five thousand and ninety nine pounds two shillings and eight pence and the further yearly rent of Seventeen pounds and nine shillings from the said tenth day of October One thousand eight hundred and sixty five in respect of the aforesaid expenditure of Three hundred and forty nine pounds six shillings and seven pence And it has been agreed that the said Henry Thompson shall pay to The Queen's Majesty an additional yearly rent of Fifteen pounds ten shillings and four pence in respect of the aforesaid expenditure of Three hundred and ten pounds five shillings and seven pence from the same day Now this Indenture witnesseth that in consideration of the premises He the said Henry Thompson Both hereby for himself his heirs executors and assigns covenant with The Queen's Majesty her heirs and successors that he the said Henry Thompson his executors assigns and

assigns will pay to the Queen's Majesty her heirs and successors the several yearly rents of Two hundred and seventy one pounds eight shillings and four pence, Seventeen pounds and nine shillings and Fifteen pounds ten shillings and four pence from the tenth day of October One thousand eight hundred and sixty five by quarterly payments on the days and in the manner mentioned in the within written Indenture for payment of the rents thereby reserved without any deduction or abatement whatsoever except for Income tax And further that the Queen's Majesty her heirs and Successors shall and may have and exercise the same powers remedies and means for recovering the said several yearly rents hereinbefore covenanted to be paid and may have and exercise the same powers of reentry into the premises demised by the within written Indenture as if the same rents had been expressly reserved and covenanted to be paid by the within written Indenture And the said James Kenneth Howard doth hereby direct that this Deed shall be deemed to be fully and sufficiently inrolled by the deposit of a duplicate thereof in the Office of Land Revenue Records and Inrolments and the filing or making an entry of such deposit by the Keeper of the said Records and Inrolments In witness whereof the said parties to these presents of the first and second parts have hereunto set their hands and seals the day and year first above written.

Dated 11th December 1866. **His Indenture** made the fourth day of December One thousand eight hundred and sixty six Between **The Queen's Most Excellent Majesty** of the first part **The Honorable James New Forest Kenneth Howard** (The Commissioner of Her Majesty's Woods Forests and Land Revenues, to whom the management and direction of certain parts of the Woods Forests and Land Revenues of the Crown included therein the Royal New Forest with the duties and powers appertaining thereto have been assigned by order under the hands of the Lords Commissioners of Her Majesty's Treasury made in pursuance of an Act passed in the session of parliament holden in the 14th and 15th years of the reign of Her present Majesty Cap: 42) of the second part and **Amelia Payne** of Beaulieu Rails in the County of Hants of the third part **Wills** by an Act passed in the session of Parliament holden in the 17th and 18th years of the reign of Her present Majesty Cap: 49 intituled "An Act for the Settlement of Claims upon and over the New Forest" After reciting or noticing therein an Act passed in the session of Parliament held in the 14th and 15th years of her said Majesty Cap: 42 intituled "An Act to extinguish the right of the Crown to Deer in the New Forest and to give compensation in lieu thereof and for other purposes relating to the said Forest" and certain subsequent Acts It was by the 29th section of the Act now in recital (17th and 18th Victoria Cap: 59) Enacted that for the purpose of defraying the expenses thereafter mentioned the Commissioners of Her Majesty's Woods Forests and Land Revenues should on behalf of Her Majesty in addition to the sales then made or agreed to be made from time to time sell and dispose of by Public Auction or Tender such parts of the open waste lands of the said Forest as they and any two Verderers of the said Forest might deem most convenient and the receipt of the Commissioners of Her Majesty's Woods Forests and Land Revenues for the time being (to whom the money to be raised by such sale was directed to be paid) should be a sufficient discharge for the purchase money to all persons purchasing who should not be bound to see to the application of the purchase money nor to enquire whether the sale was made with the assent of the Verderers as aforesaid And it was by the said Act now in recital further enacted that all acts matters and things to be done or authorised to be done by the Commissioners of Her Majesty's Woods Forests and Land Revenues in pursuance of the said Act now in recital or of the Act therein recited or any of them might be done by the Commissioner or other Officer for the time being of Her Majesty in charge of the said Forest And whereas the said James Kenneth Howard as such Commissioner of Her Majesty's Woods Forests and Land Revenues in charge of the said Forest as aforesaid acting for and on behalf of Her

Majesty and in pursuance of the provisions of the said Act of the 17th
 and 18th Vict: Cap: 49 caused certain parts of the open waste lands of the
 said Forest (which the said Commissioner and two of the Verderors of the
 said Forest deemed most convenient to be sold) to be offered for sale by
 public Auction by M^r. Frederic Ellen in the Verderors Court Room at the
 Queens House Lynton on Tuesday the 26th day of June 1866 in several
 Lots according to certain printed particulars and conditions of sale there
 and there produced at which Auction the said Amelia Payne was the
 highest Bidder for and declared to be the purchaser of Lot 93 in the
 said particulars at or for the price or sum of Ten pounds and the sum
 of Two pounds ten shillings was then and there paid by or on behalf of
 the said Amelia Payne to the said James Kenneth Howard as such
 Commissioner as aforesaid or his Agent as a deposit and in part payment of
 the said purchase money of the said Lot And whereas the said
 Amelia Payne hath requested that the hereditaments comprised in the said
 Lot may be conveyed to her as hereinafter mentioned and the said James
 Kenneth Howard as such Commissioner as aforesaid hath in pursuance of
 the said conditions of sale required the said Amelia Payne to enter into
 such covenants as are hereinafter contained Now this Indenture
 witnesseth that in pursuance of the said contract for sale and in
 consideration of the sum of Two pounds ten shillings so paid
 by way of deposit as aforesaid and of the further sum of Seven pounds
 ten shillings the Balance of the said purchase money to the said
 James Kenneth Howard as such Commissioner as aforesaid immediately
 before the execution of these presents in hand well and truly paid by
 the said Amelia Payne the receipt of which said sums of Two pounds
 ten shillings and Seven pounds ten shillings making together ten pounds

 for ever by these presents The said James Kenneth Howard as such
 Commissioner as aforesaid pursuant to and in exercise and execution of
 the power for that purpose given to or vested in him by the said
 hereinbefore recited Act of the 17th and 18th Vict: Cap: 49 and of every
 other power or authority in anywise enabling him in this behalf
 Doth by these presents for and on behalf of Her Majesty grant convey
 sell and dispose of unto the said Amelia Payne and her heirs

All those two pieces or parcels of land part of the unenclosed waste
 Lands of Her Majesty's New Forest in the said County of Hants situate
 lying and being at Pillee in the parish of Boldre in Lady Croft Walk
 in the said Forest in the said County of Hants and containing together
 by admeasurement two roods and eleven perches adjoining to land in the
 possession or occupation of Thomas Young one of which said pieces or
 parcels of land has a frontage to the Road leading from Pillee to
 Beaulieu and both which said pieces or parcels of land are comprised

 plan drawn in the margin of these presents and thereon colored Red
 Together with the appurtenances to the said hereditaments belonging and all
 timber and other trees now standing and growing thereon To have
 and to hold the said several pieces or parcels of Land hereditaments
 and premises hereinbefore described and hereby conveyed or intended so
 to be with the appurtenances and all benefits and advantages thereto
 belonging or appertaining (Subject nevertheless to such rights (if any)
 of paths roads and bridle roads as may now exist over the same)
 unto the said Amelia Payne and her heirs To the use of the said
 Amelia Payne her heirs and assigns for ever And the said Amelia
 Payne in pursuance of the conditions of the aforesaid sale doth hereby
 for herself her heirs and assigns (at the request of the said James
 Kenneth Howard as such Comptroller as aforesaid testified by his
 execution hereof) covenant with the Queen's Majesty her heirs and
 successors that she the said Amelia Payne her heirs or assigns shall
 and will at her and their expense forthwith make (Subject nevertheless
 to all proper communications for all existing paths roads and bridle
 roads if any as aforesaid) a proper and sufficient fence along the east
 side of one of the said pieces or parcels of Land as marked out and
 indicated by the Letter I on the said plan drawn in the margin hereof
 And also that the said Amelia Payne her heirs and assigns shall
 and will at the like expense when made for ever thereafter
 maintain and keep the same fence in good and proper repair and
 condition And the said James Kenneth Howard as such Comptroller
 as aforesaid doth hereby direct that this Deed shall be deemed to be
 fully and sufficiently enrolled by the deposit of a duplicate thereof



THIS INDENTURE made the third day of January One thousand eight hundred and sixty seven Between The Queen's Most Excellent Majesty of the first part The Honorable James Kenneth Howard the Commissioner of Her Majesty's Woods & Forests and Land Revenues to whom the management and direction of the Royal Forest of Dean with the duties and powers appertaining thereto have been duly assigned under the Act 14th and 15th Victoria Cap: 42 Section 5 of the second part and John Trotter of Nunham in the County of Gloucester Coal Proprietor James Wood Sully of Bridgewater in the County of Somerset Coal Proprietor and George Bryant Sully of Bridgewater aforesaid Merchant Thomas Ware of Bridgewater aforesaid Merchant and James Wood Sully the younger of Sheffield in the County of York Gentleman and which three last named persons are the Executors and Devises in fee in trust under the Will of Thomas Sully Esquire deceased and which said John Trotter, James Wood Sully George Bryant Sully Thomas Ware and James Wood Sully the younger are all trading under the style or title of the Parkend Coal Company of the third part and the said John Trotter and James Wood Sully as such Trustees as hereinafter mentioned of the fourth part


Whereas the said several persons parties hereto of the third part so constituting the said Parkend Coal Company as aforesaid are the registered owners of a certain Gale or Colliery in the said Forest of Dean called or known as Parkend Colliery and as such registered Owners lately applied to the said James Kenneth Howard as such Commissioner as aforesaid (in whom the powers given to the Commissioners for the time being of Her Majesty's Woods Forests Land Revenues Works and Buildings by the Act 1st and 2nd Vict: Cap: 43 and the 24th and 25th Vict: Cap: 40 are now vested) to grant to the said John Trotter and James Wood Sully as Trustees nominated and appointed on behalf of the said Parkend Coal Company a Lease of a piece or parcel of land part of the inclosed wasteland of the said Forest hereinafter more particularly described for the purposes hereinafter mentioned

And whereas the said James Kenneth Howard as such Commissioner as aforesaid hath agreed to grant such Lease to the said John Trotter and James Wood Sully as such Trustees as aforesaid for such term at such rent upon such conditions and subject to such covenants and restrictions as are hereinafter reserved and contained

Now this Indenture witnesseth that in consideration of the premises The said James Kenneth Howard as such Commissioner as aforesaid by virtue of every power enabling him so to do **Doth** by these presents by and with the consent and direction of the said several persons parties hereto of the third part testified by their being parties

to and severally executing these presents demise and lease unto the said John Trotter and James Wood Jolly their executors admors and assigns
All that piece or parcel of land situate lying and being at or near Brookall Ditches in Parkend or York Walk in the said Forest of Dean and County of Gloucester containing by recent admeasurement thirty six perches which said piece or parcel of land is part of the uninclosed waste land of the said Forest and is with the boundaries and abuttals thereof more particularly delineated and described on the plan drawn in the margin hereof and thereon colored red **I have and to hold** the said piece or parcel of land unto the said John Trotter and James Wood Jolly their executors admors and assigns for the term of **Seventy Six Years** from the twenty fourth day of June one thousand eight hundred and sixty six (determinable nevertheless as hereinafter mentioned) for the purpose of erecting thereon an Engine House for a Steam or Fire Engine for the purposes of and for the more convenient working of the said Parkend Gale or Colliery and to be held and used in connection therewith and for no other purpose whatsoever **Fielding and Haying** therefor yearly and every year during the said term unto the Queen's Majesty her heirs and Successors the rent or sum of **One pound** of lawful money of Great Britain to be paid half yearly on the twenty fifth day of December and the twenty fourth day of June in every year by equal payments without any deduction for Land tax or any other taxes sewers or other rates charges assessments or impositions whatsoever
And the said John Trotter and James Wood Jolly do hereby for themselves their heirs executors admors and assigns **Covenant** with the Queen's Majesty her heirs and Successors that they the said John Trotter and James Wood Jolly their executors admors or assigns will during the continuance of this demise pay unto the Queen's Majesty her heirs and Successors the said yearly rent of One pound on the days hereinbefore appointed for payment thereof without any deduction or abatement whatsoever **And also** will pay the Land tax and all other taxes sewers and other rates charges assessments and impositions whatsoever which now are or at any time during the said term may be taxed assessed or imposed upon the said demised premises or any part thereof **And also** that they the said John Trotter and James Wood Jolly their executors admors or assigns will forthwith well and sufficiently enclose and fence in the said land hereby demised to the satisfaction of the said James Kenneth Howard or other the Commissioner or other Officer or Officers for the time being exercising the powers now exercised by the said James Kenneth Howard and will during the continuance

of this demise at their own costs keep the same so well and sufficiently enclosed and fenced in as aforesaid And shall and will at all times maintain and keep the said demised premises and any Building or erection which at any time hereafter during the said term may be erected or constructed in or upon the same in good and proper repair order and condition and with all necessary and requisite drains, sewers, watercourses and amendments whatsoever and will make good all damage or injury which at any time or times during the continuance of this demise may happen or be occasioned to the lands trees property or possessions of Her Majesty or of any adjoining Owner or Owners by reason of the use or occupation of the said demised premises for the purposes aforesaid And that it shall be lawful for the said James Kenneth Howard or other the Commissioners or other Officer or Officers of the said Forest of Dean or Deputy Surveyor or Deputy Gamekeeper for the time being of the said Forest with or by their Workmen Servants or Agents from time to time and at all times during the continuance of this demise to enter into and upon the said demised premises for the purpose of viewing and examining the same and condition thereof And the said James Kenneth Howard do hereby for themselves their heirs Executors Administrators Assigns and Assignees and for the said Her Majesty the said John Trotter and James Wood Sully their heirs Executors Administrators Assigns and Assignees and for any other person or persons with out a Land Pit or Deep Pit the continuance of this demise and the said James Kenneth Howard as such Commissioners or other the Commissioners or other Officers or Officers aforesaid for that purpose first and foremost shall and will not build or set up or permit or suffer to be erected built or set up upon the said piece or parcel of land hereby demised or any part of the same any house or other building or erection or any other structure or any other thing whatsoever or any part thereof to be used or occupied otherwise than for the purposes of and in connection with the said Gale or Colliery and for the more convenient working of the same and in strict conformity with (so far as the same may be applicable thereto) the rules orders and regulations of the Dean Forest Mining Commis^{rs} made for the working of Gales pits Levels and Works of Coal or Coal mines in the said Forest of Dean and Hundred of P. Briavels and will not commit or suffer to be committed any waste spoil damage or injury to the said demised premises or any part thereof or to the adjoining lands trees property or possessions of Her Majesty or of any adjoining Owner or Owners nor do or suffer to be done any act or thing whatsoever which



expressly sanctioned or authorized to be made erected or set up nor use or occupy or permit or suffer the said demised premises or any part thereof to be used or occupied otherwise than for the purposes of and in connection with the said Gale or Colliery and for the more convenient working of the same and in strict conformity with (so far as the same may be applicable thereto) the rules orders and regulations of the Dean Forest Mining Commis^{rs} made for the working of Gales pits Levels and Works of Coal or Coal mines in the said Forest of Dean and Hundred of P. Briavels and will not commit or suffer to be committed any waste spoil damage or injury to the said demised premises or any part thereof or to the adjoining lands trees property or possessions of Her Majesty or of any adjoining Owner or Owners nor do or suffer to be done any act or thing whatsoever which

may be or become a nuisance annoyance or disturbance to the Queen's
 Majesty her heirs or successors or to the Owners or Occupiers of any
 contiguous premises And also that they the said John Trotter and
 James Wood Sully their Executors admors or assigns will at the end or
 other sooner determination of the said term peaceably and quietly
 leave surrendered and yield up unto the Queen's Majesty her heirs and
 successors or to the said James Kenneth Howard as such Commissioner
 as aforesaid or other the Commissioner or other Officer or Officers
 aforesaid on behalf of Her Majesty or to whom he or they shall
 direct or appoint to receive the same the said demised premises (except
 as hereinafter mentioned) in good and proper repair order and
 condition And also with at their own costs within three calendar
 months from the respective dates thereof cause all assignments which
 may at any time hereafter be made of these presents or of the
 premises hereby demised to be enrolled in the Office of Land Revenue
 Records and Inrolments and Minutes or Records thereof respectively to
 be entered in the Office of the said Commissioners of Her Majesty's
 Woods Forests and Land Revenues Provided always And these
 presents are granted upon this express condition that the said
 term hereby granted shall absolutely cease and determine when the
 said Parkend Gale or Colliery shall be relinquished or given up or
 cease to be worked pursuant to the rules orders and regulations of the
 Dean Forest Mining Commissioners made for working Gales Pits levels
 and Works of Coal or Coal Mines within the said Forest and Hundred
 or the grant of the said Gale or work shall be otherwise determined
 Provided also And it is hereby agreed and declared by
 and between the said parties hereto that it shall be lawful for the
 said John Trotter and James Wood Sully their Executors admors and
 assigns at any time during the said term hereby granted or within
 six calendar months after its determination by effluxion of time or
 otherwise to remove for their use and benefit any Engine Machinery
 apparatus metals building or erection whether attached to the
 freehold or not which shall or may be placed and erected in and
 upon the said demised premises by them the said John Trotter and
 James Wood Sully their Executors admors or assigns or by the said
 Parkend Coal Company they making good the damage if any done
 to the soil of the said demised premises by such removal as aforesaid
 and offering no wilful or unnecessary impediment or hindrance to Her
 Majesty her heirs or successors or to any succeeding Lessee or Grantee
 in the course of such removal Provided lastly And these

presents are upon this express condition that if the said
 rent of One pound hereby reserved or any part of the same shall be
