

appurtenances belonging thereto in good and substantial repair and at the expiration or determination of the said term to remove the said buildings and fences and level and restore the surface of the said land to the full and complete satisfaction in all respects of the Lessor;

4 To permit the Lessor or his Agents at all times to enter into and inspect the state and condition of the said premises.
