

This Indenture made the tenth day of April One thousand eight hundred and ninety nine Between The Queen's Most Excellent Majesty of the first part Edward Stafford Howard Esquire the Commissioner of Woods in charge of the premises hereinafter described of the second part and Constance Ellen Douglas Marshall of Buckstone Lodge Staunton in the County of Gloucester Widow hereinafter called the Lessee of the third part. Whereas by an Indenture made the eighteenth day of April One thousand eight hundred and ninety six Between the Queen's Most Excellent Majesty of the first part the said Edward Stafford Howard as such Commissioner as aforesaid of the second part and Henry Marshall of the third part the said Edward Stafford Howard did demise and lease unto the said Henry Marshall All that piece or parcel of land with the messuage or tenement erected thereon and more particularly described in the now reciting Indenture. To hold from the second day of May One thousand eight hundred and ninety six for the term of Seven years at the clear yearly rent of Twenty pounds.

And Whereas in erecting the said Stables a part thereof had been erected upon land outside the said premises.



Doth on behalf of Her Majesty and with the consent of the Lords Commissioners of Her Majesty's Treasury signified by their Warrant dated the fourth day of March One thousand eight hundred and ninety nine demise and lease unto the Lessee All that piece or parcel of land with the messuage or tenement erected thereon and known as Buckstone Lodge and buildings situate in the Parish of Staunton in the County of Gloucester containing One rood and twenty eight perches or thereabouts and more particularly delineated and shewn on the Plan drawn in the margin hereof and thereon colored Red. Together with the use and enjoyment during Her Majesty's pleasure of the Gateway in the fence on the North West side of the said premises into and from the plantation hatched Red on the said Plan and of the paths and rides in such plantation as a Wilderness Garden. Except and always reserved unto the Queen's Majesty Her Heirs and Successors all timber and other trees and all mines and substrata whatsoever in and upon the said demised land and premises. Permission to lay in and maintain above and to take water from the Leech Pool

Mr Baylis the Deputy Surveyor of the Forest of Dean has reported to Mr Stafford Howard your application for permission to lay a line of pipes in the direction shown by a red line on the enclosed tracing for conveying water from the Leech pool (coloured blue) to the air shaft of your colliery shown on the plan.

In reply I am to state that he is willing to give you permission to lay in and maintain the line of pipes and during the pleasure of this Department to take water from the Leech pool on the following conditions viz

A. W. Brown

30-3-99

1. The permission is to be strictly during the pleasure of this Department and to be liable to be terminated at any time by one month's notice.

2. An acknowledgment of 5/- to be paid at once to the Deputy Surveyor for the year to 5th April 1900 and a similar sum to be paid in advance on the 5th April 1900 and on the 5th April in each subsequent year during the continuance of the permission.

- (6).—The season for angling for salmon begins on the 2nd of February and ends on the 1st of November; for trout it begins on the 2nd of March and ends on the 1st of October, all dates inclusive.
- (7).—No gaff shall be used as an auxiliary to the rod and line before the 15th day of March. Licensees must provide themselves with landing nets instead.
- (8).—All fish measuring less than six inches in length from the point of the nose to the fork of the tail are to be returned to the water immediately after they are caught, except pike (jack) and eels.
- (9).—Except by special permission no angling for salmon is permitted before 8 a.m.
- (10).—Licensees must show their Crown License and Conservancy Board License when requested to do so by any water bailiff or Crown official.
- (11).—No Licensee may occupy a salmon pool or stream for more than half-an-hour when another is waiting to fish. Precedence must be taken in order of arrival, but one Licensee may fish after another at a distance of not less than 40 yards. In the event of two or more Licensees being at a pool or stream before 8 a.m. they shall draw lots for first turn, but if any one of them had the first turn on that water on the previous fishing day he shall give way.
- (12).—The License may not be lent or transferred to anyone else.
- (13).—Every Licensee shall send an accurate report to the Deputy Surveyor of the Forest of Dean, Whitemead Park, Coleford, of all salmon caught by him, giving the date and place and the state of the water, as well as particulars of the fish.
- (14).—Any Licensee selling his fish or lending his License, or acting contrary to these rules, or violating any Act of Parliament for the preservation of fish or any bye-law of the Board of Conservators of the district, or conducting himself in a manner unbecoming a gentleman, shall be liable to forfeit his License at once at the discretion of the Commissioner of Woods.
- (15).—No fishing is permitted on Sundays.
- (16).—The word "Salmon" is to be interpreted as in the Salmon Fishery Acts, 1861 to 1873.






