The Deputy Surveyor has informed Mr Stafford Howard of your application for permission to place 6 seats on the waste of the Forest at Emery Down and Lyndhurst, the sites of which are shown on a 6" O. S. Map enclosed herewith and I am directed by him to inform you that he is prepared to grant to the Lyndhurst Parish Council permission to place and during the pleasure of this Department to maintain the seats ~~on~~ the positions shown on the said map on the following terms and conditions:-

1. An acknowledgment of it is to be paid in advance to the Deputy Surveyor of the New Forest on the 5th April in each future year during the continuance of this permission the first payment in respect of the year to 5th April 1904 to be made on the acceptance of this offer.
2. The seats are to be constructed in accordance with the pencil design furnished to the Deputy Surveyor and they are to be kept in good order and condition to the satisfaction of the Deputy Surveyor.
3. In the event of this permission being determined the seats are to be removed and the ground restored to the like satisfaction.

If this offer is accepted I am to request that a certified Resolution of the Council agreeing to the terms set out herein may be forwarded to this office and the sum of it paid to the Deputy Surveyor.
