Whereas by an Indenture of Lease dated the tenth day of July One thousand nine hundred and eleven ^{and made} between The King's Most Excellent Majesty of the first part Sir Edward Stafford Howard K. B. B. then a Commissioner of Woods in charge of the hereditaments intended to be thereby demised of the second part and George Grant of Widley Park Farm Bosham in the County of Hants Esquire (therein and hereinafter referred to as ^{called} "the Lessee") of the third part All that the exclusive right of shooting and sporting upon and over All that Inclosure of Woodland called Bulls Lodge Wood otherwise Queen's Inclosure situate within the limits of the late Forest of Bere in the County of Southampton containing eighty five acres and thirty nine perches or thereabouts was subject as therein mentioned demised unto the Lessee from the first day of February 1911 for the term of Seven years at the clear yearly rent of Five Pounds payable by half yearly payments on the first day of August and the first day of February in every year during the first six years and a half of the said term and subject to the covenants and conditions therein reserved and contained amongst which was a covenant that the Lessee would pay unto the King's Majesty His Heirs and Successors the yearly rent of Five pounds upon the days and in manner aforesaid And there was therein contained a declaration that if the yearly rent should be unpaid for the space of thirty days after any of the days thereinbefore appointed for payment thereof or if the Lessee should not observe and perform the covenants contained in the said lease or any of them it should be lawful for His Majesty His Heirs and Successors or for the Commissioner on behalf of His Majesty His Heirs and Successors to determine and put an end to the right thereby granted by giving to the Lessee or leaving for him at his usual or last known place of residence in England notice in writing of his intention so to do and that immediately after the delivery or service of such notice the grant should cease and be void
